March 8th Meeting OSHA Training Institute

The OSHA Training Institute Education Center offers safety and health courses in more than 20 topics throughout Region IV, an area covering Florida, Georgia, Alabama, South Carolina, North Carolina, Mississippi, Tennessee, and Kentucky. The OSHA Training Institute (OTI) Education Centers are a national network of non-profit organizations authorized by OSHA to deliver occupational safety and health training to public and private sector workers, supervisors, and employers on behalf of OSHA. Courses offered include OSHA standards and Outreach Training Program trainer and update courses, recordkeeping, machine guarding, confined space entry, electrical standards, and fall arrest systems. There is currently at least one OTI Education Center in each OSHA Region.

Our speaker is Dr. Myrtle Turner-Harris. Dr. Turner-Harris is the Director of the OSHA Training Institute Education Center at the Georgia Tech Research Institute. She holds a PhD of Higher Education-Occupational Studies from Georgia State, a MPH in Environmental Studies from the Emory University School of Medicine, and BS in Biology also from Georgia State University. She has been the OSHATI Director since July 2005, but has been a research scientist and industrial hygienist with them since 1993. Before that she was an industrial hygienist with the General Services Administration and OSHA. Dr turner-Harris is also a Certified Environmental Trainer (CET) - National Environmental Training Association, Occupational Safety and Health Discipline since 1997.

IH Corner EPA Proposes Changes to Risk Management Program

Newly proposed changes to EPA's Risk Management Program (RMP) regulations are intended to improve chemical process safety at RMP facilities and modernize the agency's chemical safety and security regulations, guidance, and policies. The proposed revisions would affect EPA's accident prevention program requirements, and would enhance emergency planning and preparedness requirements; increase the availability of chemical information to help the public understand the risks at RMP facilities; and require third-party audits and root-cause analysis to identify process safety improvements for accident prevention. EPA also proposes to require the assessment of inherently safer technologies and designs during process hazard assessment.

These proposed revisions are an "action item" under an executive order issued in August 2013 to improve chemical facility safety and security, and would specifically affect EPA's Accidental Release Prevention Requirements of RMP under section 112(r) of the Clean Air Act.

The new proposed rule has yet to be published in the *Federal Register*, but EPA has made a pre-publication copy of the proposed amendments available on the agency's website.

After its publication, the public will have 60 days to submit written comments to EPA.

OSHA in Georgia

Employer name: FPL Food LLC

Investigation site: 1301 New Savannah Road, Augusta, Georgia 30901

Citations issued: The U.S. Department of Labor's Occupational Safety and Health Administration issued citations to the employer on Feb. 26 for 15 serious safety violations.

Investigation findings: OSHA initiated an investigation after learning a worker was hospitalized after a workplace injury. On Dec. 3, 2015, a hydraulic saw lacerated the abdomen of a 36-year-old saw operator as he cut meat. The worker was severely injured. OSHA discovered that the saw's safety cut-off switches were not functioning properly.

The agency cited FPL Food LLC for exposing workers to falls on platforms without rails; electric shock from improper wiring; and amputations from unguarded cutting blades. Additionally, the employer did not provide a fully functional eyewash station for workers handling leaking batteries. The company also failed to train workers on the specific procedures to prevent machinery from starting up during maintenance and servicing.


Quote: "The results of this investigation clearly indicate that FPL Food's safety and health management plan is ineffective and not being enforced," said William Fulcher, OSHA's area director in the Atlanta-East Office. "Management must make worker safety its top priority and be engaged in enforcing it."

Proposed penalties: \$67,270

FPL Food is a fresh meat processor that prepares, packs and ships beef products to food service and retail customers. The company employs nearly 400 workers in Augusta. The employer has 15 business days from receipt of its citations and proposed penalties to comply, request a conference with OSHA's area director or contest the findings before the independent Occupational Safety and Health Review Commission.

Ladder Safety App

NIOSH has updated its ladder safety app based on users' feedback. Introduced in 2013, the app had been downloaded more than 52,000 times by the end of 2015, and it has been promoted by state officials, industry leaders, and safety professionals, they reported, with some companies incorporating it in their safety policies. It also earned a merit award from the Digital Health Awards, a program that recognizes the world's best digital health resources for consumers and health professionals. The app's appearance, content, and function have been improved, and it now includes stepladder safety and additional interactive tools. More than 500,000 people per year are treated, and about 300 people die, per year from ladderrelated injuries in the US costing \$11 billion per year.

Comparing Safety

A new report from UL details the health conditions and workplace safety rates in every state, as well as their financial impact. The report can be found here: http://www.ulworkplace.com/wp-content/uploads/UL_State-Reports.pdf

Published in January by UL's Integrated Health & Safety Institute, the report breaks down data for each state and compares it with the national average. Data points include prevalence of diabetes, heart diseases and obesity; workplace injury and illness and fatality rates also are covered.

The report sums up each state's direct and indirect expenditures associated with health care, lost productivity and days of absence costs. Additionally, workers' compensation data for a five-year period is included.

The areas of the country with the highest prevalence (compared with the national average) of various adverse health conditions were mostly located in Southern states, whereas the Great Plains had among the highest prevalence of workplace fatalities.

"The insight [gleaned] from this information will help [employers] identify and understand potential issues that, if managed through an integrated health and safety framework, could prevent and/or reduce injuries and illnesses in the workplace," IHSI Global Director Todd Hohn said in the report's introduction.

ASSE Salary Survey Reveals Strong Income Potential for OSH Professionals

Park Ridge, Illinois (July 30, 2015) – A 2015 American Society of Safety Engineers survey of more than 9,000 occupational safety and health professionals reveals they earn an annual base salary on average of \$98,000, an increase of \$8,000 since the survey was taken two years ago. The ASSE survey results are part of an expansive collaboration with the American Board of Industrial Hygiene (ABIH), Alliance of Hazardous Materials Professionals (AHMP), American Industrial Hygiene Association (AIHA), Board of Certified Safety Professionals (BCSP) and Institute of Hazardous Materials Management (IHMM). The complete results from the 2015 survey in addition to an interactive calculator are available online at www.asse.org/salarysurvey.

The survey found professionals with at least one of the 11 certifications measured in the survey make on average over \$14,000 more annually than a professional without one of these certifications and over \$30,000 more annually than the typical Occupational Health and Safety Specialist, according to the number reported by the Bureau of Labor Statistics (BLS).

Chapter Education Assistance
