#### IH Corner How Many Samples Should I Take

The purpose of industrial hygiene sampling is to determine the concentration or level of a particular stressor. The greater the number of samples, the better the chance that the range of results will include all possible values. This is typically presented as a standard deviation or upper and lower confidence level. But this is limited to sampling the same operation or homogenous exposure group.

If your IH program is in-house, you should strive for as many samples as you can afford. I have seen texts that say you don't have a good "N" until you have 29 or more samples. This will be expensive in staff, equipment, and lab costs.

If you outsource your program, the same number applies, but since you must rely on consultants your budget is typically harder to justify. As such, I would recommend a sample strategy that aims at worst case scenarios. Select high production days, or use other factors that will skew results higher (indoor vs outdoor, continuous vs intermittent, heavy vs light, etc. The assumption being that if your worst day is below the PELs or TLVs, then your lighter days may be okay. Be careful with approach though and be honest to yourself. OSHA will pick the day they think is highest for their sampling.

## Groundsman killed after he was hit in the head by stray golf ball

A groundsman was killed in a freak accident after he was hit in the head by a stray ball on a golf course. Maurice Hayden collapsed to the ground after he was hit in the temple by the errant tee shot. The 42-year-old was less than 30 yards away from the player at the Mayfair Country Club in Sanford, Florida, when he sliced his shot.

Michael Galloway, who witnessed the accident, said: 'It hit him right in the temple at 135 or whatever miles an hour a drive is, that's a pretty severe blow.' Paramedics desperately tried to revive Mr Hayden before he was rushed to hospital and placed on a life support machine. But he never regained consciousness and died a day later.

Officials at the club said he had been pulling weeds from near a tree when the shot hit him. Police said the golfer, who is said to be distraught, will not face any charges. Sanford police sergeant David Morgenstern said: 'It was just an unfortunate accident. 'The golfer just didn't see the worker, and the worker didn't see him.'

# H&S QUIKSTAT 22,000 Hearing Loss Cases

Thousands of workers every year continue to suffer from preventable hearing loss due to high workplace noise levels. Since 2004, the Bureau of Labor Statistics has reported that more than 125,000 workers have suffered significant, permanent hearing loss. In 2008 alone, BLS reported 22,000 hearing loss cases.

According to Dr. David Michaels, Assistant Secretary of Labor for occupational safety and health, "There is sufficient evidence that hearing protection alone cannot prevent workers from suffering preventable hearing loss."
